Through training excellence, this program will enable you to successfully lead areas, teams, projects, organizations and the creation of innovative companies with a focus on responsible and sustainable growth.





Application

If you wish to apply for any of the scholarships offered by the CMI Foundation, you must send a motivation letter and scholarship application expressing your interest in applying to the program, and send all the documentation to: universal@cmiuniversal.com

The selection of candidates will be made by the Admissions Committee integrated by the CMI Direction.

Registration

The result of the admission process will be communicated to the candidate by e-mail. In the case of being admitted, to formalize the enrollment process, the final reservation fee must be paid.

The enrollment process can be carried out throughout the year, although it is subject to the availability of vacancies.

Candidates without a university degree may be admitted by demonstrating relevant professional experience as a source of knowledge and skills in our admission criteria to maximize the positive impact of the students and Institute. In this case, a minimum of 10 years of work experience will be required and an objective entrance test, consisting of the writing of a developed current issue, which will be designated for each candidate.
